Official Rules

1. Jet Stream Casino and Washita Casino are governmental enterprises of the Chickasaw Nation, ("Nation") a federally recognized sovereign Indian tribe. Jet Stream Casino and Washita Casino are giving away combined prizes for the "Max and Lucky's Ultimate Giveaway" promotion on Monday, March 11, 2019.
2. Patrons must be and 18 years of age or older with a valid photo I.D., with complete and accurate information to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Jet Stream Casino and Washita Casino; employees of the Nation prohibited from participating as set forth by any of the Nation's policies, regulations or laws; anyone who has been barred from any of the Nation's gaming facilities; or any promotional sponsors.

Starting Monday, March 11, 2019 at 8:00am through Friday, March 15, 2019 at 5:00pm patrons who follow both Jet Stream and Washita Casino's Facebook page, like the "Max and Lucky's Ultimate Giveaway" Facebook post on either Jet Stream or Washita Casino's Facebook page and tag one friend will be eligible for a chance to win the following:

Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
