

Gift of the Month Washita Casino

Official Rules

1. Washita Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Washita Casino is giving away featured gifts for the month of October for the “Gift of the Month” promotion.
2. Patrons must be 18 years of age or older with a valid photo I.D. and must be a Washita Casino player’s card member, with complete and accurate account information, to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Washita Casino; employees of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations, or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. During the month of October from 10-1 to 10-7, 10-8 to 10-14, 10-15 to 10-21, and 10-22 to 10-28, qualified Patrons who earn 200 points while playing with their Washita Players club card will get a featured gift of the month item while supplies last. (Gifts Valued between \$20 and \$60)
 - a.) Patrons must earn points on their Washita Player’s Club Card by playing Electronic Games during the qualifying time period, The Qualifying time period starts at 8am the first day of each time period and ends at 11:59pm on the last day of each time period, and report to the Players Club or cashier cage.
 - b.) Patron(s) must be present to win.
 - c.) Limit of one (1) Gift per Patron per date range.
 - d.) Washita Casino management may substitute any prior Gift of the Month gift for the current month’s Gift based on availability.
 - e.) Washita Casino’s casino management system will be the sole determinant of each winner.
4. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable provided by the Chickasaw Nation.
5. Acceptance of prize constitutes winner’s permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winners must agree to sign a publicity release form before prize will be released.
6. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
7. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
8. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
