

# **Riding Into Summertime Sweepstakes**

## **Washita Casino April/May Promotion**

### **Official Rules**

1. Washita Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Washita Casino is giving away up to \$10,000 in cash and prizes during the “Riding into Summertime Sweepstakes” promotion.
2. Patrons must be 18 years of age or older and have a valid photo I.D. and must be a Washita Casino Players Card member, with complete and accurate account information, to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Washita Casino; employees of the Nation prohibited from participating as set forth by any of Nation’s policies, regulations, or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. Beginning Monday, April 1, 2019 through Friday, May 31, 2019 Patrons will be able to earn entries for the drawings in the following ways:
  - A) Patrons will receive one (1) entry for every five (5) points earned on their Washita Casino Players Card. Partial entries will not carry over once drawings begin.
  - B) Patrons who are new Washita Casino Players Card members will receive five (5) entries upon initial enrollment.
  - C) Every Wednesday throughout promotion, Patrons will receive five (5) entries for every five (5) points earned on their Washita Casino Players Club Card.
  - D) Double entries will be awarded every Sunday and Monday throughout the promotion.
  - E) Selected Patrons receiving offers via any direct marketing initiative will be able to redeem offers for additional entries and/or a single entry as specified on the offer.
4. On Fridays, April 26, and May 31, 2019 drawings will be held from 6:00pm to 9:00pm and \$2,000 in cash and prizes will be given away as five (5) \$50, five (5) \$100, and five (5) \$250 winners and at approximately 9:00pm a grand prize drawing will be held and one winner will receive a John Deere Z355E Zero Turn Mower (valued at \$2,999).
  - A) Patrons are responsible for activating their entries by properly inserting their Washita Casino Players Card into an electronic gaming machine and removing their Washita Casino Players Card from the machine within thirty (30) minutes of the drawing times.
  - B) Patron(s) must be present to win. Winner(s) will be announced and have two (2) minutes to respond. However, if the announced winner does not respond within the allotted time a new winner will be drawn.
  - C) Limit of one (1) preliminary prize per Patron per night during this promotion.
  - D) All Patrons eligible for grand prize drawing.
  - E) Limit of one (1) grand prize per patron during this promotion.
  - F) Washita Casino’s casino management system will be the sole determinant of each winner.
5. If for any reason, a winner refuses a prize, there will be no cash option and a new winner will be drawn.
6. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/ or a 1099 tax form, when applicable provided by the Chickasaw Nation.

7. Acceptance of prize constitutes winner's permission for Nation to use his/her likeness name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prize will be released.
8. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/ or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
9. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
10. Participation in this promotion and/ or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
