Official Rules

1. Washita Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Washita Casino is giving away up to \$4,000 in cash during the “Fall Cash Bash” promotion.
2. Patrons must be 18 years of age or older and have a valid photo I.D. and must be a Washita Casino Players Card member, with complete and accurate account information, to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Washita Casino; employees of the Nation prohibited from participating as set forth by any of Nation’s policies, regulations, or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. On the following Fridays: October 9 and 23, 2020, a total of ten (10) random hot seats will be held from 6:00 pm until 9:00 pm and up to \$2,000 in cash will be given away each night.
 - A) Patron(s) must be present and actively playing on a participating electronic gaming machine at the time of each drawing to be eligible to win. All participating electronic gaming machines will be designated with a balloon.
 - B) In order to qualify as “actively playing”, a Patron must be seated at an electronic gaming machine with a playable amount of credits (in accordance to the machine’s minimum playable wager) at the time of each drawing.
 - C) The patron who is seated at the machine drawn will be the primary winner and receive \$100 in cash. The patron(s) seated to the immediate left and right of the primary winner will be the secondary winner(s) and receive \$50 each. There can be up to ten (10) primary and twenty (20) secondary winners on each of the aforementioned dates.
 - D) In the event that no one is seated at the primary machine, a new winner will be drawn.
 - E) Limit of one (1) primary win per patron, per night during this promotion.
 - F) Washita Casino’s manual drawing system will be the sole determinant of each winner.
4. If for any reason, a winner refuses a prize, there will be no cash option and a new winner will be drawn.
5. Casino Management reserved the right to ask Patrons who are not actively playing to relinquish their electronic gaming machine.
6. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/ or a 1099 tax form, when applicable provided by the Chickasaw Nation.

7. Acceptance of prize constitutes winner's permission for Nation to use his/her likeness name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prize will be released.
8. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/ or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
9. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
10. Participation in this promotion and/ or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
